# MEMBERSHIP RULES FROM D.G.S.A. LTD ARTICLES

## RENEWALS

11. A member ceases to be a member of the Society:
- (e) If he/she has not paid his annual subscription on or before the last day of December. Persons who wish to rejoin the Society after that date must apply for membership in the normal way and pay the fees applicable to new members, that is annual subscription and prefix fees. Payment of the fees DOES NOT confer the right to receive back copies of the Society's publications.
81. A person is deemed to be resident wherever he/she has his/her breeding herd.
100. Unless and until otherwise determined by the Council each member must pay the fees and annual subscriptions as fixed by the Council from time to time.
101. A person who is accepted as a new member three months or less prior to the end of the current financial year of the Society need pay no annual subscription in the succeeding financial year PROVIDED that the person was not a financial member of the Society during any of the three years prior to acceptance.
102. The annual subscription must be paid to the Federal Secretary.
